Rule Proposed: Fishing is solely for Tonkawa Springs residents and their guests. Fishing is catch and release only. Please respect our ponds and wildlife.

- Discuss Bylaw changes that may be needed at future meeting and action items in accordance with required legislative law SB 1588 and other laws passed in May 2021 legislative session
 - a. **Meeting Notice for Board Meetings –** Pg. 5 section 13 of bylaws due to amended section 209.0051 of Texas Property Code
 - Budget Voting Pg. 7 section 20 of bylaws due to amended section 209.0051 of TPC. All budget changes must now be voted upon in open sessions during properly noticed meetings.
 - c. Neighborhood Website tonkawasprings.org mandatory item that TSHOA Board must maintain going forward. Can no longer be voluntary
 - d. Resale Certificates Motion needed to adopt Proposed Fee Change law limits amt to \$ 375 for resale certificate and \$ 75 for updated certificate and need to set price for optional rush fee. This will impact budgets moving forward

- e. **ACC** Pg. 9 Article V of bylaws due to SB1588. A current board member, spouse, or someone residing in member's residence is not to be on the ACC. Also, will require additional policy around denials, variances, etc.
- f. Management Certificate Required to be filed with Wilco as well as TREC. Does HOA need to adopt policy/procedure to ensure updates provided to county and TREC are done as required?
- q. Collections Policy Does HOA need to adopt policy regarding this legislation?
