### What Happened to the Pond Remediation Plan?

On December 30, 2022 the TSHOA board temporarily suspended the vote for the Pond Remediation Plan after receiving feedback from HOA attorney Clint Brown. The purpose of the re-set was to maintain the objective of restoring health to the ponds through the processes proposed in the Fall of '22, but in a way that better aligned with the HOA purview and guidelines. On January 12, 2023, the new board approved the formation of a Pond and Dam Remediation Committee in order to move forward with a revised plan to achieve this objective.

What about Wilco? On February 21, 2023 board members met with Commissioner Valerie Covey and Wilco engineer Terron Evertson to evaluate what, if any, level of assistance the county might be able to provide. The initial feedback from the Commissioner's office is that Wilco can and will make any necessary repairs/improvements to the part of Tonkawa Trail that traverses the dam, and up to 15' on either side of the road. This includes removing trees and foliage from the dam, but does NOT at this point include repair to the spillway itself, as that is 100% HOA property, and not the County's. Taking this into consideration, and after considering a number of options, the Pond and Dam Remediation Committee has come up with the following recommendations:

- 1. The Pond Remediation Plan will no longer be sponsored by or involve the TSHOA. Instead, the plan will be hosted and maintained by a group of homeowners, under a non-profit founded and organized by the same. The TSHOA, though a pond owner, will not be encumbered by any aspect of the plan initiated by the private homeowners. A plan that reflects most of the previous components and similar costs as the one submitted in the Fall will soon be re-submitted to all affected pond property owners for consideration. We hope that installation and treatment with Aquatic Features Inc can still begin sometime in May, with ongoing clean-up efforts prior to that.
- 2. Separate the Dam Repair components entirely from the Pond Remediation program. Repairs to the dam/spillway on the big pond (#4) on the west side of Tonkawa Trail will still be the sole responsibility of the HOA, as it is part of the HOA property. Repairs to the dam on pond (#3) to the east side will be the sole responsibility of a group of homeowners on that pond. The Board will vote on engaging with a dam engineer at the Q2 meeting in order to determine extent of the degredation to the dam and a general scope of repairs. The results will be presented for community review and vote at a later date. Pending funding approval by the community, dam repairs would likely not begin until late summer in any case at the earliest, when water levels are lower.

Summary: Because the TSHOA is going to have enough on its hands getting the dam on its property fixed, it was determined that pond owning residents shoud not wait for that part to be resolved. Though the dam repairs are obviously important to the overall health of the pond system, the pond remediation efforts could proceed without the Association's involvement, and prior to the dam being fixed.
